

RESOLUTION NO. 2025-019

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO
ELK GROVE MUNICIPAL CODE SECTIONS 3.42.180(B)(4) AND 3.42.220 AND
AUTHORIZING THE CITY MANAGER TO EXECUTE A THREE-YEAR CONTRACT
FOR MICROSOFT SOFTWARE THROUGH A COOPERATIVE PURCHASING
AGREEMENT WITH CDW GOVERNMENT, LLC IN AN AMOUNT
NOT TO EXCEED \$785,663.49**

WHEREAS, the City of Elk Grove (City) currently utilizes Microsoft cloud-based software; and

WHEREAS, the evolving technology and collaboration tools available with Microsoft cloud-based software provides cost savings and flexibility; and

WHEREAS, pursuant to Elk Grove Municipal Code Sections 3.42.180(B)(4) and 3.42.220, which provide an exception to the formal bidding procedure when the purchase is processed through a cooperative purchasing agreement; and

WHEREAS, County of Riverside has a pre-negotiated purchasing agreement with CDW Government. LLC (CDW-G), which may be utilized by other government organizations when the software is purchased through CDW-G as the reseller.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal bidding procedure pursuant to Elk Grove Municipal Code Section 3.42.180(B)(4) and 3.42.220, and authorizes the City Manager to execute a three-year contract for Microsoft software through a cooperative purchasing agreement with CDW Government, LLC, in substantially the form presented, in an amount not to exceed \$785,663.49.
