**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AMENDING THE FISCAL YEAR 2024-25 BUDGET AND THE 2024-2029 CAPITAL
IMPROVEMENT PROGRAM TO REMOVE THE BOND ROAD STORM DRAIN
IMPROVEMENTS PROJECT (WDR022) FROM THE CAPITAL IMPROVEMENT
PROGRAM**

WHEREAS, the City of Elk Grove Storm Drainage Master Plan (SDMP), published in June 2011, identified a deficiency in the existing storm drain trunk line in Bond Road for meeting the performance criteria for a 10-year rainfall event; and

WHEREAS, the Bond Road Storm Drainage Improvements Project (WDR022) was added to the 2014-2019 Capital Improvement Program (CIP); and

WHEREAS, the computer model of the City's storm drainage system used in the SDMP used assumptions that require further analysis during project design; and

WHEREAS, observations from the storm on October 21, 2024 demonstrated that the existing Bond Road storm drain can experience flows from a storm event exceeding that of a 100-year event without causing property damage; and

WHEREAS, data from the storm on October 21, 2024 was utilized to re-calibrate the stormwater computer model; and

WHEREAS, the re-calibrated stormwater model for the Bond Road system demonstrates that the City's performance criteria are being met.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby amends the Fiscal Year 2024-2025 Budget and 2024-2029 Capital Improvement Program as shown in Table 1:


