

RESOLUTION NO. 2025-032

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DECLARING THE RESULTS OF THE SPECIAL ELECTION HELD ON
FEBRUARY 26, 2025, AND ORDERING THE ANNEXATION OF TERRITORY
TO COMMUNITY FACILITIES DISTRICT NO. 2006-1 (MAINTENANCE SERVICES)
(ANNEXATION NO. 101)**

WHEREAS, in proceedings heretofore conducted by the City Council (the “City Council”) of the City of Elk Grove (the “City”), pursuant to the Mello-Roos Community Facilities Act of 1982, as amended (the “Act”), the City Council on February 26, 2025, adopted Resolution No. 2025-031 which resolution called a special election within the territory proposed to be annexed to the City’s Community Facilities District No. 2006-1 (Maintenance Services) (the “CFD”); and

WHEREAS, pursuant to the terms of the resolution, the special election was held on February 26, 2025, and the City Clerk has duly canvassed the returns of the election and has filed with the City Council a statement of all votes cast at the election showing the whole number of votes cast within such territory and the whole number of votes cast for and against the measure in such territory and also filed, attached to the statement, his certificate as to the correctness of the statement (the “Statement of Election Results”), a copy of which is attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove as follows:

Section 1. Approval of Canvass. The canvass by the City Clerk, as shown by the Statement of Election Results is hereby ratified, confirmed, approved, and entered upon the minutes of this meeting.

Section 2. Statement of the Measure. At the election, the following measure was submitted to the qualified electors of the territory proposed to be annexed to the CFD and the number of votes cast for and against the measure was as follows:

Shall the City of Elk Grove be authorized to levy a special tax at the rates and apportioned as described in Exhibit B to the Resolution Declaring its Intention to Annex Territory to Community Facilities District No. 2006-1 (Maintenance Services) adopted by the City Council on January 8, 2025 , (the “Resolution”), which is incorporated herein by this reference, within the territory identified on the map entitled “Annexation Map No. 101 of Community Facilities District No. 2006-1 (Maintenance Services), City of Elk Grove, County of Sacramento,” to finance certain services as set forth in Exhibit A of the Resolution?

Section 3. Votes Cast. The total number of votes cast in the territory proposed to be annexed to the CFD at the election was 21.

Section 4. Measure Failed. All of the votes cast at the election on the measure were against the measure and the measure failed.

Section 5. Validity of Procedures. The City Council hereby finds and determines that all prior proceedings and actions taken by the City Council pursuant to the Act were and are valid and in conformity with the Act.

Section 6. No Further Proceedings. Based on the written protests and votes against the proposed Annexation No. 101 of territory to the existing community facilities district, there are no further proceedings to annex the territory of Annexation No. 101.

Section 7. Recording of the Resolution Declaring the Results of the Special Election. The City Clerk is hereby directed to record a certified copy of this resolution with the Sacramento County Recorder.


