**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE THE MEMORANDUM OF
UNDERSTANDING BETWEEN THE CITY OF SACRAMENTO, THE COUNTY OF
SACRAMENTO, THE CITY OF ELK GROVE, AND THE SACRAMENTO MUNICIPAL
UTILITY DISTRICT REGARDING COORDINATION AND COOPERATION ON
BUILDING ELECTRIFICATION EFFORTS**

WHEREAS, on September 28, 2022, the City Council authorized participation in a no-cost Memorandum of Understanding (MOU) with the City and County of Sacramento and the Sacramento Municipal Utility District (SMUD); and

WHEREAS, the MOU approved in 2022 expired in March 2025; and

WHEREAS, the MOU establishes a process to coordinate and collaborate on new building and existing retrofit electrification projects, policies, and activities within participating jurisdictions; and

WHEREAS, the City of Elk Grove (City) is at risk of experiencing the devastating effects of extreme heat and weather events caused by rising atmospheric greenhouse gasses, resulting in climate change; and

WHEREAS, equitable building electrification represents a major GHG reduction for the City and will result in improved air quality and overall health; and

WHEREAS, participation in the MOU will lead to increased information sharing, avoid duplication of work, provide for shared learning, help assure an equitable and just transition, and demonstrates to state and federal funding partners an existing, collaborative framework; and

WHEREAS, the building electrification MOU does not create any ordinance or regulation and does not tie the City to any other jurisdiction's actions.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Memorandum of Understanding between the City of Sacramento, the County of Sacramento, the City of Elk Grove, and the Sacramento Municipal Utility District regarding coordination and cooperation on building electrification efforts, in substantially the form presented.
