

RESOLUTION NO. 2025-093

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO WAIVE A FORMAL ACCOUNTING OF THE
WALTER GERARD HART REVOCABLE TRUST AND CONSENT TO DISTRIBUTION
OF TRUST ASSETS, AND AMENDING THE BUDGET FOR ANIMAL SERVICES IN
THE AMOUNT OF \$153,316**

WHEREAS, Walter Gerard Hart established the Walter Gerard Hart Revocable Trust in which, upon his death, he bequeathed twenty percent of his estate to the Elk Grove Animal Shelter; and

WHEREAS, Walter Gerard Hart died on December 22, 2024; and

WHEREAS, the Trustee of the trust has determined that trust assets in the amount of \$153,316 are available for distribution to the Elk Grove Animal Shelter; those funds will be placed in a restricted donation fund for the Elk Grove Animal Shelter; and

WHEREAS, other trust assets may later become available to the Elk Grove Animal Shelter; and

WHEREAS, the Elk Grove Animal Shelter and the City of Elk Grove express their sincere appreciation to Mr. Hart for his generous bequest to the Elk Grove Animal Shelter which will be used to assist the Shelter in its mission to improve the lives of animals in its care.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to:

- 1) Waive a formal accounting of the Walter Gerard Hart Revocable Trust;
- 2) Consent to distribution of trust assets in the amount of \$153,316;
- 3) Accept or reject future trust distributions of trust assets; and
- 4) Execute all necessary documentation to effectuate the acceptance or rejection of trust assets, in a form approved by the City Attorney;

AND, BE IT FURTHER RESOLVED that the City Council of the City of Elk Grove hereby authorizes an amendment to the donation budget for Animal Services in the amount of \$153,316 and as otherwise required to adjust for future distribution of trust assets.
