**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A GOODS AND SERVICES  
CONTRACT WITH KONGSBERG PRECISION CUTTING SYSTEMS, US, LLC FOR  
THE PURCHASE OF A GTE KONGSBERG X24 EDGE 3KW WITH CONVEYOR  
INCLUDING INSTALLATION IN AN AMOUNT NOT TO EXCEED \$145,000**

**WHEREAS**, the City of Elk Grove (City) has identified the need to improve in-house fabrication capabilities for signage and related materials; and

**WHEREAS**, the City has determined that the GTE Kongsberg X24 Edge 3kW with Conveyor provides functionality, efficiency, and compliance features necessary to meet operational demands; and

**WHEREAS**, an invitation to bid was duly advertised on April 4, 2025, and April 11, 2025, and electronic bids were received on April 22, 2025; and

**WHEREAS**, Kongsberg Precision Cutting Systems, US, LLC was determined to be the responsible bidder submitting the lowest responsive bid; and

**WHEREAS**, funding for this purchase is available in the approved FY 2024-25 Budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a goods and services contract with Kongsberg Precision Cutting Systems, US, LLC, in substantially the form presented, for the purchase of a GTE Kongsberg X24 Edge 3kW with Conveyor including installation in an amount not to exceed \$145,000.
