

RESOLUTION NO. 2025-101

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT AMENDMENT WITH CITIZENS TELECOMMUNICATIONS COMPANY OF CALIFORNIA INC. DBA FRONTIER TO PROVIDE TELEPHONE AND INTERNET SERVICES TO THE CITY OF ELK GROVE FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$1,719,300

WHEREAS, Citizens Telecommunications Company of California, Inc. dba Frontier (Frontier) currently has infrastructure in place to provide needed telephone and internet services to the City of Elk Grove (City); and

WHEREAS, Frontier is the only provider of copper phone lines on City campuses; and

WHEREAS, Frontier has successfully provided these services to the City for approximately 25 years; and

WHEREAS, the Police Department's non-emergency dispatch lines and citywide building alarm systems are provided by Frontier; and

WHEREAS, the previous contract between the City and Frontier expired on March 29, 2023, and Frontier has continued to provide services to the City despite the expiration. This amendment will backdate to the expiration of the previous contract and set a new contract termination date of March 31, 2027, with the option to extend the agreement via a writing signed by the City Manager, subject to Budget approval; and

WHEREAS, for the reasons presented, issuing a formal request for proposals for the subject services is not in the best interest of the City and would not likely result in more beneficial services or costs.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedure pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) and authorizes the City Manager to execute a four-year contract amendment with Citizens Telecommunications Company of California, in substantially the form presented, to provide telephone and internet services to the City of Elk Grove for a total contract amount not to exceed \$1,719,300.
