

RESOLUTION NO. 2025-118

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.140(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE MASTER SERVICES CONTRACT WITH INTERWEST CONSULTING GROUP, INC. FOR FEDERAL/STATE FUNDED PROJECT MANAGEMENT SERVICES (C-21-300), TO INCREASE THE TOTAL COMPENSATION AMOUNT BY \$500,000 (FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$3,500,000)

WHEREAS, the City of Elk Grove (City) utilizes consultants to perform Public Works Department services; and

WHEREAS, the existing Master Services Contract for federally and/or state funded Public Works Department services has fully utilized all funding; and

WHEREAS, the continuation of these services is vital to the completion of Public Works projects; and

WHEREAS, for the reasons presented, it is not in the best interest of the City to pursue the formal request for proposal procedure as provided in Elk Grove Municipal Code Section 3.42.140(B)(3).


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby finds that a formal request for proposal procedure is not in the best interest of the City and dispenses with the formal procedure pursuant to Elk Grove Municipal Code Section 3.42.140(B)(3) and authorizes the City Manager to execute an amendment to the Master Services Contract with Interwest Consulting Group, Inc. for Federal/State funded project management services (C-21-300), in substantially the form presented, to increase the total compensation amount by \$500,000 (for a total contract amount not to exceed \$3,500,000).
