

RESOLUTION NO. 2025-119

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ADOPTING THE TITLE VI PROGRAM FOR THE CITY OF ELK GROVE AND
AUTHORIZING STAFF TO SUBMIT THE NECESSARY DOCUMENTATION TO THE
FEDERAL HIGHWAY ADMINISTRATION FOR REVIEW AND APPROVAL**

WHEREAS, Title VI of the Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, or national origin in programs and activities receiving federal financial assistance; and

WHEREAS, the City of Elk Grove's (City) Title VI Program was last updated in May 2018, with Resolution No. 2018-095, and the City no longer operates the Elk Grove transit system and as such, no longer receives federal funding from the FTA; and

WHEREAS, the Department of Public Works and Capital Improvement Program are recipients of federal funding from the Federal Highway Administration (FHWA); and

WHEREAS, staff has updated the Title VI Program in accordance with 42 U.S.C. Section 2000d, which states that "No person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving federal financial assistance"; and

WHEREAS, the City is committed to ensuring that no person is excluded from participation in, denied the benefits of, or otherwise subjected to discrimination under any of its programs, activities, or services on the basis of race, color, or national origin.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby

- 1) Adopts the City's Title VI Program and authorizes staff to submit the necessary documentation to the FHWA for review and approval; and.
- 2) Authorizes staff to make any necessary changes, amendments, or revisions to the City's Title VI Program to ensure compliance with the United States Code.
