**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE
ELK GROVE UNIFIED SCHOOL DISTRICT FOR THREE ELK GROVE POLICE
DEPARTMENT POLICE OFFICERS ASSIGNED AS SCHOOL RESOURCE
OFFICERS IN THE AMOUNT OF \$1,683,489.92, AND PROVIDING BUDGETARY
AUTHORITY FOR A MODIFICATION TO THE FISCAL YEAR 2025-26 BUDGET
RELATED TO THE AGREEMENT WITH ELK GROVE UNIFIED SCHOOL DISTRICT**

WHEREAS, School Resource Officers (SROs) work on campuses throughout the Elk Grove Unified School District (EGUSD) providing law enforcement expertise to assist school staff with maintaining a safe environment; and

WHEREAS, in an effort to assist with providing a safe learning environment for Elk Grove students, the Elk Grove Police Department (EGPD) has provided SROs to EGUSD since 2017; and

WHEREAS, EGPD and EGUSD have found the partnership and collaboration to be invaluable to both parties and the Elk Grove community; and

WHEREAS, EGUSD has requested to have three Elk Grove police officers assigned to work as SROs at Elk Grove schools for the next three school years; and

WHEREAS, EGUSD will pay for approximately 70% and the City will pay for approximately 30% of all costs associated with the Elk Grove police officers assigned as SROs.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

1. Authorizes the City Manager to execute an agreement with the Elk Grove Unified School District, in substantially the form presented, for three Elk Grove police officers assigned as School Resource Officers in the amount of \$1,683,489.92.
2. Provides budgetary authority for the following modification to the Fiscal Year 2025-26 Budget within the General Fund:
 - a. Increasing the Community Services miscellaneous revenue budget in the amount of \$124,816 for salaries and benefits reimbursement from EGUSD.
