**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
APPROVING CONTINUED PARTICIPATION IN THE SACRAMENTO FUEL
NETWORK, AUTHORIZING A CONTRIBUTION OF UP TO \$10,000 TO THE FUEL
NETWORK FOR THE BENEFIT OF ELK GROVE RESIDENTS, AND AMENDING THE
FISCAL YEAR 2025-26 BUDGET**

WHEREAS, the City Council resolved at the November 8, 2017, Regular City Council Meeting, to participate in the “Sacramento Family Unity, Education, and Legal Network for Immigrants” Network (the “FUEL Network”); and

WHEREAS, the City of Elk Grove (City) previously provided the sum of \$10,000 in funding for legal assistance for Deferred Action for Childhood Arrivals (DACA) recipients residing in Elk Grove and for specific FUEL Network workshops; and

WHEREAS, the FUEL Network has recently requested renewed funding from the City to extend their free legal services to Elk Grove residents who are directly impacted by current federal immigration policies and practices.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:


- 1) Approves continued participation in the FUEL Network; and
- 2) Authorizes a contribution of up to \$10,000 to the Sacramento Family Unity, Education, and Legal Network for Immigrants” (FUEL) for the benefit of Elk Grove residents; and
- 3) Approves an amendment to the Fiscal Year 2025-26 City Council Budget for this purpose.
