**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A FUNDING AGREEMENT
WITH THE SACRAMENTO METROPOLITAN CABLE TELEVISION COMMISSION TO
ACCEPT PUBLIC EDUCATION AND GOVERNMENT CHANNEL FACILITIES FEES
IN THE AMOUNT OF \$42,522 AND AMENDING THE
FISCAL YEAR 2025-26 INFORMATION SERVICES BUDGET TO REFLECT
REVENUE AND EXPENDITURES RELATED TO FUNDS AWARDED**

WHEREAS, the City of Elk Grove (City) will be awarded \$42,522 in Public Education and Government (PEG) Channel Facilities fees from the Sacramento Metropolitan Cable Television Commission (Metro Cable) for Fiscal Year 2025-26; and

WHEREAS, the City will utilize the funding to upgrade outdated equipment in the Council Chambers AV room; and

WHEREAS, the City will seek reimbursement from Metro Cable after the funds have been expended, but before June 30, 2026.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute the Funding Agreement with the Sacramento Metropolitan Cable Television Commission, in substantially the form presented, accepting Public Education and Government (PEG) Channel Facilities Fees in the amount of \$42,522, and amends the Fiscal Year 2025-26 Information Services budget to reflect revenue and expenditures related to funds awarded.
