**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE ONE REIMBURSEMENT
AGREEMENT WITH JEN CALIFORNIA 18, LLC, FOR PRIVATELY CONSTRUCTED
PUBLIC FACILITIES INCLUDED IN THE ELK GROVE ACTIVE TRANSPORTATION
FEE PROGRAM AND CONSTRUCTED FOR THE BENEFIT OF THE SHELDON
FARMS NORTH PROJECT**

WHEREAS, Elk Grove Municipal Code Section 16.95.070 provides for reimbursement to developers for the private construction of any facilities designated in the Elk Grove Active Transportation Fee Program subject to entering into a reimbursement agreement with the City of Elk Grove (City); and

WHEREAS, JEN California 18, LLC, is constructing trail improvements in the northwestern part of the City and identified in the Elk Grove Active Transportation Fee Program as eligible for reimbursement.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute one Credit Reimbursement Agreement with JEN California 18, LLC, in substantially the form presented, for privately constructed facilities, which are eligible for reimbursement from the Elk Grove Active Transportation Fee Program as follows:


