

RESOLUTION NO. 2025-166

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT FOR GOODS
WITH CUBIC ITS, INC. FOR THE PURCHASE OF SIX TRAFFIC SIGNAL CONTROL
CABINETS AND OTHER COMPONENTS AND ACCESSORIES IN AN AMOUNT NOT
TO EXCEED \$133,050; AND AMENDING THE FY 2025-26 BUDGET IN FUND 328,
ELK GROVE ROADWAY FEES**

WHEREAS, the City of Elk Grove (City) requires traffic signal control cabinets and related equipment to support new development and ensure timely construction of signalized intersections; and

WHEREAS, an invitation to bid was duly advertised on June 6, 2025, and June 15, 2025, and electronic bids were received on June 24, 2025; and

WHEREAS, Cubic ITS, Inc. was determined to be the responsible bidder submitting the lowest responsive bid; and

WHEREAS, staff is recommending an amendment to the FY 2025-26 Budget in a total amount of \$133,050 in Elk Grove Roadway Fees (Fund 328); and

WHEREAS, the City will be reimbursed for this expense through Roadway Impact Fees collected from developers of new construction projects, with no credits issued specifically for the use of City-purchased cabinets, as outlined in the updated November 2022 Roadway Fee Program.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby:

- 1) Authorizes the City Manager to execute a contract for goods with Cubic ITS, Inc. for the purchase of six traffic signal control cabinets and other components and accessories in an amount not to exceed \$133,050; and
- 2) Amends the FY 2025-26 Budget as follows:
