**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
DISPENSING WITH THE FORMAL BIDDING PROCEDURE PURSUANT TO ELK
GROVE MUNICIPAL CODE SECTION 3.42.180(B)(4) (COOPERATIVE PURCHASING
AGREEMENT) AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN
AGREEMENT WITH CDW GOVERNMENT, LLC FOR THE PURCHASE OF LENOVO
LAPTOP REPLACEMENTS IN AN AMOUNT NOT TO EXCEED BUDGETED
AMOUNTS AND AMENDING THE FISCAL YEAR 2025–26 INFORMATION
SERVICES BUDGET TO INCLUDE AN ADDITIONAL \$102,000, TRANSFERRED
FROM THE 603 FUND BALANCE TO FUND THE PURCHASE**

WHEREAS, the City of Elk Grove (City) purchased laptops over five years ago, which have reached the end of their useful life, are becoming increasingly unreliable, and must be replaced to maintain operational efficiency and support for City staff; and

WHEREAS, pursuant to Elk Grove Municipal Code (EGMC) Section 3.42.180(B)(4), the City Council may dispense with the formal bidding procedure when the purchase is processed through a cooperative purchasing agreement; and

WHEREAS, CDW Government, LLC (CDW-G) is a vendor under a valid cooperative purchasing agreement that meets the purchasing requirements of EGMC Chapter 3.42; and

WHEREAS, the City of Mesa Contract #2024056-01 for Information Technology Products and Services has secured competitive pricing for this commodity and the City of Elk Grove may take advantage of this pricing.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal bidding procedure pursuant to Elk Grove Municipal Code Section 3.42.180(B)(4) (Cooperative Purchasing Agreement), and authorizes the City Manager to execute an agreement with CDW Government, LLC, in substantially the form presented, for the purchase of Lenovo laptop replacements in amounts not to exceed budgeted amounts as set forth in the City's annual budget and amending the Fiscal Year 2025–26 Information Services budget to include an additional \$102,000, transferred from the Fund 603 fund balance to fund the purchase.
