

RESOLUTION NO. 2025-199

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE DISPENSING WITH THE FORMAL REQUEST FOR PROPOSAL PROCEDURE PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.188(B)(3) AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO CONTRACT NO. C-19-316 WITH GRANICUS, LLC FOR PUBLIC MEETING MANAGEMENT SOFTWARE, EXTENDING THE TERM FOR THREE YEARS AND INCREASING THE CONTRACT AMOUNT BY \$249,638.89, FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$523,435.77

WHEREAS, Granicus, LLC (Granicus) is an industry leader in streaming software for public meetings; and

WHEREAS, Granicus, LLC has successfully provided public meeting streaming services to the City of Elk Grove (City) for the past 20 years; and

WHEREAS, the current contract with Granicus expires in early December 2025; and

WHEREAS, given the City's long-standing relationship with Granicus and staff's familiarity with their platform, Granicus is uniquely positioned to continue providing these critical services without disruption; and

WHEREAS, for the reasons presented, a formal request for proposal procedure for the subject services is not in the best interest of the City.


NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby dispenses with the formal request for proposal procedures pursuant to Elk Grove Municipal Code Section 3.42.188(B)(3) and authorizes the City Manager to execute the third amendment to Contract No. C-19-316 with Granicus, LLC, in substantially the form presented, for public meeting management software, extending the term for three years and increasing the contract amount by \$249,638.89, for a total contract amount not to exceed \$523,435.77.
