

**RESOLUTION NO. 2025-221**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
APPROVING THE ANNUAL DEVELOPMENT IMPACT FEE REPORT FOR FISCAL  
YEAR 2024-25 AND MAKING FINDINGS REQUIRED BY THE MITIGATION FEE ACT**

**WHEREAS**, pursuant to the Mitigation Fee Act (California Government Code Section 66000, *et seq.*) certain findings are required to be made regarding unexpended development impact fees in connection with consideration of the Annual Development Impact Fee Report; and

**WHEREAS**, the Annual Development Impact Fee Report for Fiscal Year 2024-25 identifies impact fee programs for which there are unexpended development impact fees for which findings are required.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby approves the Annual Development Impact Fee Report for Fiscal Year 2024-25.

**AND BE IT FURTHER RESOLVED** that the City Council of the City of Elk Grove hereby finds the following as required by Government Code Section 66001(d) based upon review of the Annual Development Impact Fee Report for Fiscal Year 2024-25:

- 1) That the purpose of the development impact fees has been identified.
- 2) That there is a continued need for the improvements and that there is a reasonable relationship between the fees and the impacts of development for which the fees are collected.
- 3) The sources and amounts of funding anticipated to complete the financing of improvements have been identified.
- 4) The approximate dates for funding improvements are included in the City's 2025-2030 Capital Improvement Program unless the improvements are longer term projects or are planned by another agency.
