**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE FINANCE DIRECTOR TO DISPOSE OF SURPLUS CITY  
PROPERTY PURSUANT TO ELK GROVE MUNICIPAL CODE SECTION 3.42.310  
IN THE FORM OF ONE UNMANNED AERIAL SYSTEM AND ASSOCIATED  
ACCESSORIES, THROUGH DONATION TO THE CITRUS HEIGHTS POLICE  
DEPARTMENT**

**WHEREAS**, the City of Elk Grove (City) purchased Unmanned Aerial Systems (UAS) and associated accessories to be utilized by the Elk Grove Police Department in the normal course of duties; and

**WHEREAS**, staff has designated one UAS and related accessories as surplus as it has reached the end of its service life based on years in service, and the availability of new and enhanced technology software; and

**WHEREAS**, Elk Grove Municipal Code (EGMC) Section 3.42.310 establishes procedures for the disposition of surplus property, including donation to public bodies, charitable, civic, or nonprofit organizations; and

**WHEREAS**, the City desires to surplus one UAS and associated accessories, and donate it to another law enforcement agency, namely, the Citrus Heights Police Department.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the Finance Director to exercise the disposal of surplus City property in the form of one UAS and associated accessories, as described, through donation to the Citrus Heights Police Department:

- One Autel EVO II Dual Enterprise UAS and associated accessories (battery, propellers, and charger case), Serial No. HA292151103.
