

RESOLUTION NO. 2026-009

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ESTABLISHING A PREFERENTIAL PARKING PERMIT ZONE ON AMBER WAVES
WAY, AMBER FIELDS COURT, PURPLE SKIES COURT, AND MAJESTIES COURT**

WHEREAS, on October 8, 2014, the City of Elk Grove (City) adopted Ordinance No. 27-2014 to allow for Preferential Parking Permit Zones (PPPZ), which is codified at Elk Grove Municipal Code (EGMC) Chapter 10.26; and

WHEREAS, residents of Amber Waves Way, Amber Fields Court, Purple Skies Court, and Majesties Court in the area near Pleasant Grove High School are experiencing limited available parking near their homes during school hours; and

WHEREAS, more than 75% of the residents on each of Amber Waves Way, Amber Fields Court, Purple Skies Court, and Majesties Court have signed a petition requesting to have a Preferential Parking Permit Zone established on their streets; and

WHEREAS, the request satisfies the requirements of Elk Grove Municipal Code (EGMC) Chapter 10.26; and

WHEREAS, staff from Public Works have reviewed the request and recommend establishing a PPPZ on school days from 8:00 a.m. to 4:00 p.m. at Amber Waves Way, Amber Fields Court, Purple Skies Court, and Majesties Court.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Elk Grove that a Preferential Parking Permit Zone is hereby established on Amber Waves Way, Amber Fields Court, Purple Skies Court, and Majesties Court pursuant to EGMC Chapter 10.26, as indicated on the attached Exhibit A, incorporated herein by reference, with preferential parking permits to be issued by the Public Works Director or designee to any resident living on one of the above-referenced streets, and for the street upon which the resident lives, and at no cost for parking permits issued to a resident living on one of the above-referenced streets.

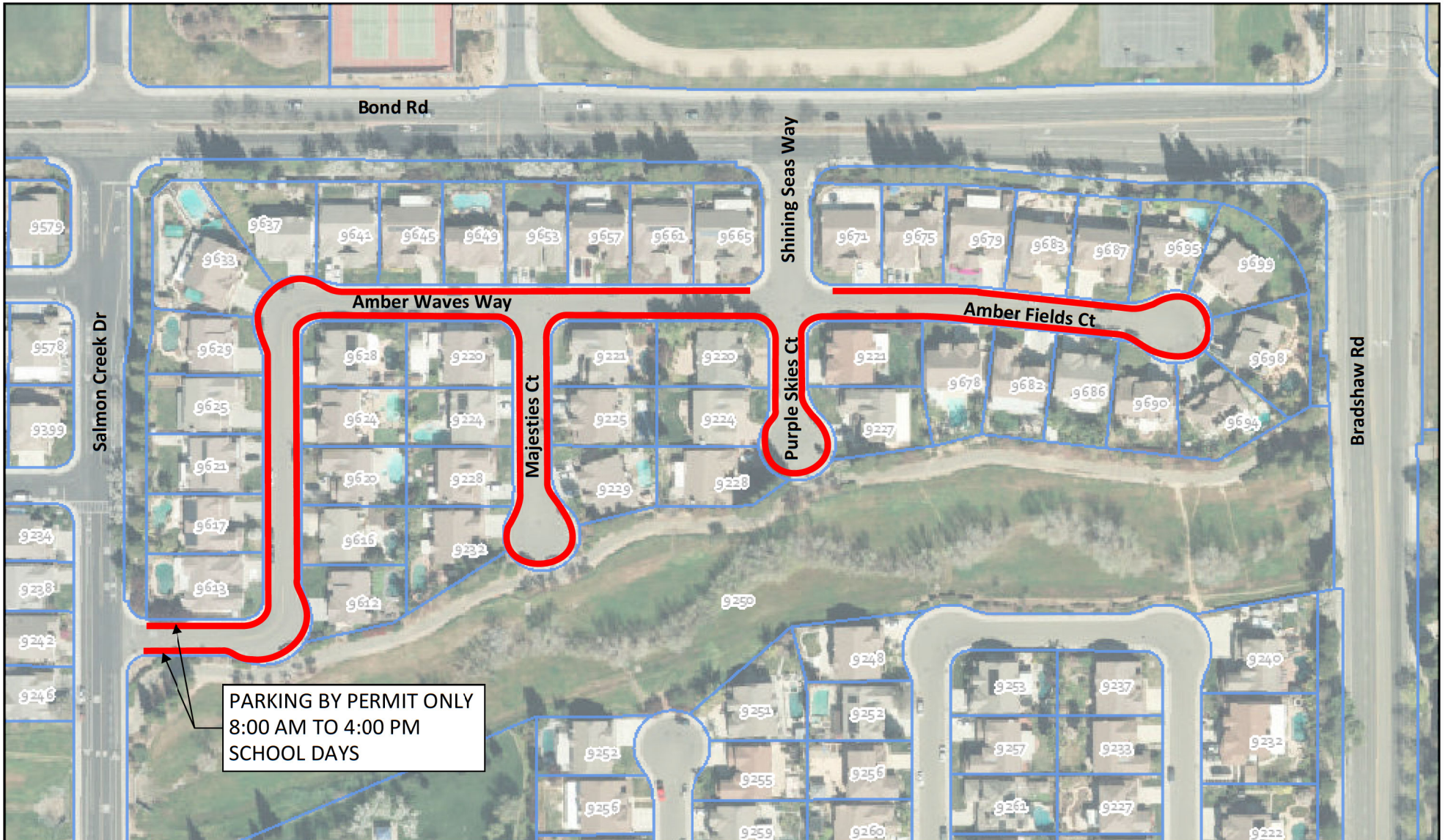
