

## RESOLUTION NO. 2026-020

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE ONE AGREEMENT FOR ACQUISITION OF PRIVATELY-CONSTRUCTED FACILITIES OR REIMBURSEMENT OF ELIGIBLE EXPENDITURES WITHIN THE CITY OF ELK GROVE COMMUNITY FACILITIES DISTRICT NO. 2005-1 (LAGUNA RIDGE) BY AND BETWEEN THE CITY OF ELK GROVE AND LENNAR HOMES OF CALIFORNIA, LLC, A CALIFORNIA LIMITED LIABILITY COMPANY, UTILIZING FUNDS FROM THE CFD 2005-1 SERIES 2025 BONDS PURSUANT TO THE LAGUNA RIDGE COMMUNITY FACILITIES DISTRICT GUIDING PRINCIPLES**

**WHEREAS**, development within the geographic area included in the Laguna Ridge Specific Plan area (the “Plan Area”) requires the construction of public facilities and improvements; and

**WHEREAS**, on March 8, 2006, the City Council adopted Resolution No. 2006-62 (the “Resolution of Formation”) and thereby established a community facilities district known as the City of Elk Grove Community Facilities District No. 2005-1 (Laguna Ridge) (“CFD 2005-1”), pursuant to the Mello-Roos Community Facilities Act of 1982, as amended (Government Code Sections 53311, et seq.; and

**WHEREAS**, the City has, in conjunction with the developer of properties within Arbor Ranch Phase 3, determined to finance certain facilities and/or certain impact fees through CFD 2005-1, and the authorization of special tax levies and bond issues that will be used in part to pay for the public facilities and improvements and/or impact fees; and

**WHEREAS**, Lennar Homes of California, LLC, a California limited liability company, (the “Developer”) constructed or will construct certain of the improvements that serve CFD 2005-1 (the “Projects”) and/or has paid or will pay certain impact fees (the “Impact Fees”), the costs of which are described in Exhibit A-2 (“Reimbursement Request”) and Exhibit A-4 (“Approved Maximum Reimbursement Payment”) to the Acquisition and Reimbursement Agreement with the Developer for its project that supported the CFD 2005-1 Series 2025 net bond proceeds; and

**WHEREAS**, the City and the Developer desire to enter into one Agreement to acknowledge the construction of the Project in accordance with the requirements for acquisition by the City, and payment of required Citywide Development Impact Fees that are listed as eligible for reimbursement in the adopted Resolution of Formation for the CFD, in order to release in a timely manner the Laguna Ridge CFD 2005-1 Series 2025 funds that are calculated as the Developer’s share pursuant to the Laguna Ridge Community Facilities District Guiding Principles that were adopted by Council on March 9, 2016, as Resolution No. 2016-048.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute one Agreement for Acquisition Privately-Constructed Facilities or Reimbursement of Eligible Expenditures within the City of Elk Grove Community Facilities District No. 2005-1 (Laguna Ridge) with Lennar Homes of California, LLC, a California limited liability company, in substantially the form presented, for its development of the residential subdivision listed below, which is eligible for reimbursement from the Series 2025 net bond proceeds for privately-constructed

facilities within the City of Elk Grove Community Facilities District No. 2005-1 (Laguna Ridge) and/or for eligible development impact fees paid at building permit for the project described in the Acquisition and Reimbursement Agreement.


