PROJECT DESCRIPTION: The Milestone II GPA, Rezone, and Map Project (the "Project") consists of a General Plan Amendment/Community Plan Amendment (map) to change the land use designation from Public Services (PS) to Low Density Residential (LDR); a Rezone from RD-5 to RD-6; and a Tentative Subdivision Map and Subdivision Design Review to subdivide the site into 56 single family lots and one lot for stormwater treatment. The Project also includes a Determination of Consistency with the General Plan for the Abandonment of existing right-of-way that is not necessary for present or foreseeable future use.

This is to advise that on September 10, 2025, the City of Elk Grove City Council approved the above-described Project and made the following determinations regarding the above-described project.

1. On the basis of the whole record, there is no substantial evidence that the Project as designed and mitigated will have a significant effect on the environment. An Initial Study/Mitigated Negative Declaration (IS/MND) has been prepared and completed in accordance with the CEQA. The Mitigated Negative Declaration reflects the independent judgment and analysis of the City;
2. Pursuant to Public Resources Code, Section 21081 and CEQA Guidelines, Section 15091, all the proposed mitigation measures described in the Mitigated Negative Declaration are feasible, and therefore shall become binding upon the City; and
3. To the extent that these findings conclude that various proposed mitigation measures outlined in the IS/MND are feasible and have not been modified, superseded or withdrawn, the City Council hereby binds itself and their assigns and successors in interest to implement those measures. These findings are not merely informational but constitute a binding set of obligations that will come into effect when the City constructs the Project.

Pursuant to CEQA and the CEQA Guidelines, the City prepared an IS/MND for the Project and mitigation measures have been developed that will reduce potential environmental impacts to less than significant levels. Preparation of a Mitigation Monitoring and Reporting Program (MMRP) is required in accordance with the City of Elk Grove regulations and state law, which is designed to ensure compliance during project implementation.

The City distributed the Notice of Intent to Adopt the MND on June 13, 2025. It was posted at the Sacramento County Clerk's office, distributed through the State Clearinghouse and at the City offices, pursuant to Section 15072 of Chapter 3 of Title 14 of the California Code of Regulations (State CEQA Guidelines). A 30-day review and comment period was opened on June 13, 2025, and closed on July 14, 2025. The MND was made available to the public during this review period. During the public review period, staff received four comment letters on the IS/MND. The comments do not alter the conclusions of the IS/MND as described in the staff report for the Project. The comments received did not identify any new significant effect, substantial increase in severity of an impact identified in the IS/MND, or any significant new information. Therefore, recirculation of the IS/MND is not warranted.

The IS/MND determined that the proposed Project would not result in any environmental impacts that could not be mitigated to a less than significant level. On the basis of the IS/MND, environmental analysis, and the whole record, there is no substantial evidence that the Project will have a significant adverse impact on the environment above those addressed within the adopted Mitigated Negative Declaration.
