

RESOLUTION NO. 2026-055

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE FOUR CONTRACTS WITH CSG CONSULTANTS; TOWILL, INC.; R.E.Y ENGINEERS, INC.; AND WOOD RODGERS, INC. FOR MAP REVIEW AND SURVEYING SERVICES FOR THE DEVELOPMENT ENGINEERING DIVISION OF THE COMMUNITY DEVELOPMENT DEPARTMENT, EACH WITH A THREE-YEAR TERM WITH AN OPTIONAL TWO-YEAR EXTENSION IN AN AMOUNT NOT TO EXCEED THE AMOUNT BUDGETED FOR THIS WORK IN THE ADOPTED FISCAL YEAR BUDGET FOR EACH YEAR OF THE CONTRACT TERM

WHEREAS, the Development Engineering Division of the Community Development Department is responsible for review of subdivision maps and related surveying documents in accordance with the Subdivision Map Act, Elk Grove Municipal Code, and applicable City standards; and

WHEREAS, the City of Elk Grove (City) issued a Request for Proposals (RFP) on December 19, 2025, for Map Review and Surveying Services to support the City's review of subdivision maps and related surveying documents; and

WHEREAS, proposals were received on January 23, 2026, and evaluated by a panel of City staff, and based on the evaluation of proposals and interviews staff recommends awarding contracts to CSG Consultants; Towill, Inc.; R.E.Y Engineers, Inc.; and Wood Rodgers, Inc.; and

WHEREAS, costs for these services are the financial responsibility of private development project applicants, with funds programmed each year in the annual budget process and managed through individual task orders.


NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute contracts with CSG Consultants; Towill, Inc.; R.E.Y Engineers, Inc.; and Wood Rodgers, Inc., in substantially the forms presented, to provide Map Review and Surveying Services for the Development Engineering Division of the Community Development Department, each with a three-year term and an optional two-year extension and in an amount not to exceed the amount budgeted for this work in the respective fiscal year budgets for each year of the contract term.
