

RESOLUTION NO. 2026-078

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
ADOPTING AN UPDATED ANIMAL LICENSE FEE SCHEDULE**

WHEREAS, the City of Elk Grove (City) has authority to establish animal licensing fees and requires dogs and cats residing within the City to be licensed; and

WHEREAS, the City Council last amended the Animal License Fee Schedule on February 27, 2013; and

WHEREAS, the City wants to align the Animal License Fee Schedule with those of neighboring agencies and ensure appropriate cost recovery for services provided; and

WHEREAS, the proposed fees do not exceed the estimated reasonable cost to provide the services; and

WHEREAS, Elk Grove Municipal Code Section 8.03.010 License required – Fees has been amended to add a two-year license period to the current one- and three-year license periods, necessitating the addition of a fee for the two-year license; and

WHEREAS, a public hearing notice containing the proposed fee schedule was duly published, as required by law, and a public hearing on the proposed fees was held on April 22, 2026.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby adopts and approves the following Animal License Fee Schedule for dogs and cats residing within the City of Elk Grove effective July 1, 2026:

Spayed/Neutered	\$20	\$40	\$50
Unaltered	\$60	\$120	\$165
Senior Spayed/Neutered (first 2 pets)	Free	Free	Free
Senior Spayed/Neutered (3rd+)	\$20	\$40	\$50
Senior Unaltered	\$30	\$60	\$83
Microchip Exemption	\$50	\$100	\$150
Late Fee	\$20	-	-
Dangerous	-	-	\$500

This Fee Schedule shall be effective on July 1, 2026, and shall supersede any and all previously adopted fee schedules for Animal Licenses in the City of Elk Grove.


