

**RESOLUTION NO. 2026-093**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
ADOPTING UPDATED USER FEES FOR THE ELK GROVE AQUATICS CENTER**

**WHEREAS**, the Elk Grove Aquatic Center (EGAC) opened to the public in May 2019 as part of the District56 recreational campus; and

**WHEREAS**, in October 2017, the City of Elk Grove (City) entered into a management agreement with the Cosumnes Community Services District (CCSD) to operate the EGAC, and CCSD provides a variety of programs including swim lessons and aquatic fitness classes, hosts special events, and manages facility rentals at EGAC; and

**WHEREAS**, the City Council initially adopted EGAC user fees in July 2018 and last updated them in December 2023 to remain current with market conditions and align with aquatics fees at other CCSD facilities within the City; and

**WHEREAS**, the CCSD Board of Directors adopted an updated fee schedule in December 2025, which includes revised pricing for certain aquatics programs; and

**WHEREAS**, in order to remain consistent with CCSD pricing as the facility operator and with prevailing market rates, City staff recommends updating the EGAC user fee schedule.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby finds that the fees identified in Exhibit A, attached hereto and incorporated herein by reference, do not exceed the reasonable costs to the City to provide the services identified, and hereby adopts and approves such user fees for the Elk Grove Aquatics Center, effective as of the date of this Resolution; and

**BE IT FURTHER RESOLVED** that this Resolution, and the fees adopted hereunder, supersede any previously adopted fees for these services at the Elk Grove Aquatics Center, including those adopted with Resolution Nos. 2023-276, 2021-145, 2020-033, 2019-115, 2019-186, and 2018-153.


