**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
AUTHORIZING THE CITY MANAGER TO EXECUTE A MASTER SERVICES
CONTRACT WITH INTERWEST CONSULTING GROUP, INC., FOR DEPARTMENT
OF PUBLIC WORKS SERVICES FOR A FIVE-YEAR TERM WITH AN OPTIONAL
EXTENSION, IN AN AMOUNT NOT TO EXCEED THE AMOUNT BUDGETED FOR
THIS WORK IN THE ADOPTED FISCAL YEAR BUDGET FOR EACH YEAR OF THE
CONTRACT TERM SUBJECT TO CITY COUNCIL APPROVAL**

WHEREAS, the City of Elk Grove (City) utilizes consultants to perform services within the Department of Public Works including on-call professional project management services and general professional services; and

WHEREAS, the City issued a Request for Proposals (RFP) on January 13, 2026, for on-call professional project management services and general professional services to manage the programmatic aspects of the City's infrastructure, as well as some general services to manage the labor and material tasks necessary to implement maintenance repairs; and

WHEREAS, proposals were received on February 19, 2026, and evaluated by a panel of City staff, and based on the evaluation of proposals staff recommend awarding a contract to Interwest Consulting Group, Inc. for Department of Public Works services; and

WHEREAS, costs for these services shall be programmed each year in the annual budget process, subject to City Council approval.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a Master Services Contract with Interwest Consulting Group, Inc., in substantially the form presented, for Department of Public Works Services for a five-year term with an optional extension, in an amount not to exceed the amount budgeted for this work in the adopted fiscal year budget for each year of the contract term, subject to City Council approval.
