

**RESOLUTION NO. 2026-105**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
RECOMMENDING TO THE SACRAMENTO PUBLIC LIBRARY AUTHORITY BOARD  
OF DIRECTORS THAT THE MEETING ROOM AT THE NEW ELK GROVE LIBRARY  
BRANCH BE NAMED IN HONOR OF PATRICIA SANDEFUR AND DIRECTING THE  
CITY MANAGER TO SUBMIT THE RECOMMENDATION TO THE LIBRARY  
AUTHORITY BOARD OF DIRECTORS FOR CONSIDERATION**

**WHEREAS**, the City of Elk Grove (City), in partnership with the Sacramento Public Library Authority (Library Authority), is finalizing the development of the new Elk Grove Branch Library facility; and

**WHEREAS**, while the City provides the library's physical space and facility assets, the library is operated by the Library Authority, a Joint Powers Authority governed by the Sacramento Public Library Authority Board, which maintains explicit operational responsibility for interior spaces within library facilities across all member jurisdictions pursuant to the Joint Exercise of Powers Agreement; and

**WHEREAS**, Patricia Sandefur's distinguished career as a librarian has been defined by her extraordinary dedication to the community, providing instrumental leadership in the operation and development of regional library infrastructure; and

**WHEREAS**, while City facilities are not normally named after living persons, the City Council finds that Ms. Sandefur's career-long impact and status as a cornerstone of local library history provides sufficient justification for this honor, notwithstanding her status as a living individual; and

**WHEREAS**, the Library Authority does not currently have a formally adopted naming policy for interior spaces, and the City does not want to unilaterally name a room within a space governed by the Library Authority; and

**WHEREAS**, the adoption of a formal Resolution recommending this honor to the Library Authority's Board of Directors is a procedural pathway to signify the City's strong support for recognizing Ms. Sandefur's legacy of service to the library system and the residents of Elk Grove.




