

## RESOLUTION NO. 2026-102

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE AUTHORIZING THE CITY MANAGER TO EXECUTE A JOINT CONTRACT BETWEEN THE CITY OF ELK GROVE, COSUMNES COMMUNITY SERVICES DISTRICT, AND NBS GOVERNMENT FINANCE GROUP FOR FINANCIAL ANALYSIS AND COST ALLOCATION OF ASSETS FOR A TERM OF ONE YEAR IN AN AMOUNT NOT TO EXCEED \$175,200; AND AUTHORIZING THE CITY MANAGER, IN COORDINATION WITH THE GENERAL MANAGER OF THE COSUMNES COMMUNITY SERVICES DISTRICT, TO JOINTLY APPROVE AND EXECUTE AMENDMENTS TO THE CONTRACT TO ADD ADDITIONAL SCOPES OF WORK IN AN AMOUNT NOT TO EXCEED AN ADDITIONAL \$50,000**

**WHEREAS**, the City of Elk Grove (City) and the Cosumnes Community Services District (District) are independent entities and each currently own, operate, and maintain various landscape medians, trails, streetscapes, storm drainage facilities (creeks and channels), parks, recreational facilities, and open spaces; and

**WHEREAS**, both agencies entered into a joint initiative—CLEAR (Collaborative Local Efficiency Alignment Review)—to clarify ownership, streamline maintenance responsibilities, and establish well-defined operational and financial accountability across all public spaces; and

**WHEREAS**, a formal Request for Proposal process was conducted with three responsive proposals received; and

**WHEREAS**, staff from both agencies are recommending entering into a joint contract with NBS Government Finance Group (NBS) to provide this service; and

**WHEREAS**, NBS has a strong understanding of and experience with existing funding structures of both agencies, a deep understanding of cost allocation and lifecycle costing, as well as revenue eligibility analysis; and

**WHEREAS**, the joint contract has a total contract amount not to exceed \$175,200 and all work costs will be split 50/50 between the City and the District; and

**WHEREAS**, sufficient funds are available in the adopted FY 2025-26 Public Works Department Budget for the City's \$87,600 share of the Contract amount; and

**WHEREAS**, an additional \$25,000 needed to cover the City's share of potential future amendments has been included in the Public Works Department's proposed FY 2026-27 Budget and is subject to future City Council action to adopt the FY 2026-27 Budget.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Elk Grove hereby authorizes the City Manager to execute a joint contract between the City of Elk Grove, Cosumnes Community Services District and NBS Government Finance Group for Financial Analysis and Cost Allocation of Assets, in substantially the form presented, for a term of one year and a total contract amount not to exceed \$175,200.


**AND, BE IT FURTHER RESOLVED** by the City Council of the City of Elk Grove that the City Manager, in coordination with the General Manager of the Cosumnes Community Services District, is hereby authorized to jointly approve and execute amendments to the joint contract to add additional scope of work, provided that such amendments do not increase the total contract amount by \$50,000, with costs to be shared equally between the parties, such that \$25,000 shall be the responsibility of the City and \$25,000 shall be the responsibility of the District, or whatever lesser amount is approved and equally shared.


