

**RESOLUTION NO. 2026-112**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE  
AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH  
MUNICIPAL RESOURCE GROUP, LLC TO PROVIDE MENTORSHIP AND  
DEVELOPMENT TRAINING TO CITY STAFF FOR A TERM OF THREE YEARS IN  
AN AMOUNT NOT TO EXCEED \$113,786**

**WHEREAS**, the City of Elk Grove (City) conducted a formal Request for Proposal process for qualified firms to provide mentorship and development training services to staff; and

**WHEREAS**, after reviewing all proposals received, staff is recommending the City contract with Municipal Resource Group, LLC (MRG) to provide mentorship and development training to City staff; and

**WHEREAS**, MRG has extensive experience in mentorship and leadership development, and since 2021 has proven competent in providing these services to City staff and has a deep understanding of the City's objectives for the program; and

**WHEREAS**, MRG has proposed enhancing the program to include the strategic engagement of alumni within cohorts, quarterly webinars, an expansive resource library, and participants' membership to the "Evolve" Leadership Development Platform, which includes access to a foundational six-module course designed to equip leaders at all levels with a common language and essential tools for effective people management.


